LEGAL DESCRIPTION

THE WEST HALF OF THE SOUTHWEST QUARTER OF SECTION 25, TOWNSHIP 3 NORTH, RANGE 7 EAST OF THE WILLAMETTE MERIDIAN, SKAMANIA COUNTY, WASHINGTON, EXCEPTING THEREFROM THE FOLLOWING PARCELS:

1. THE WEST 20 FEET OF THE SOUTH 400 FEET THEREOF.
2. THAT PARCEL DEEDED TO JOHN W. SKAAR, ET UX, BY DEED RECORDED APRIL 6, 1976 IN BOOK 70 ON PAGE 778. (TAX LOT 201)
3. COMMENCING AT THE NORTHWEST CORNER OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 25, TOWNSHIP 3 NORTH, RANGE 7 EAST OF THE WILLAMETTE MERIDIAN, SKAMANIA COUNTY, WASHINGTON, AND RUNNING THENCE SOUTH $88^{\circ} 36' 22''$ EAST, 662.25 FEET TO AN IRON PIPE; THENCE CONTINUING ON THE SAME COURSE AN ADDITIONAL 20 FEET; THENCE SOUTH $00^{\circ} 40' 35''$ WEST, 661.26 FEET; THENCE NORTH $88^{\circ} 29' 45''$ WEST, 20 FEET; THENCE SOUTH $00^{\circ} 40' 35''$ WEST, 334.03 FEET; THENCE NORTH $87^{\circ} 25' 54''$ WEST, 307.56 FEET TO AN IRON PIPE; THENCE NORTH $00^{\circ} 36' 13''$ EAST, 328.32 FEET TO AN IRON PIPE; THENCE NORTH $88^{\circ} 29' 45''$ WEST, 353.59 FEET TO AN IRON PIPE ON THE WEST LINE OF SAID SECTION 25; THENCE NORTH ALONG THE WEST LINE OF SAID SECTION, 659.96 FEET TO THE PLACE OF BEGINNING;

RESERVING HOWEVER, UNTO THE GRANTORS AND THEIR ASSIGNS, A RIGHT OF WAY FOR INGRESS, EGRESS AND UTILITIES ACROSS THE MOST EASTERLY 30 FEET OF THE PARCEL CONVEYED BY THIS DEED, SAID RESERVATION TO BE IN FAVOR OF THE OWNERS OF THE LAND DESCRIBED IN NO. 3 ABOVE.
