# CENTERLINE DESCRIPTION

Beginning at the Skamania County brass monument marking the north quarter corner of Section 28, Township 3 North, Range 8 East, W.M.; thence N 88° 22' 08"E 869.51 feet to the initial point of herein described, said point being Station 49+00, which is a P.O.C. on a 1600 foot curve to the left; thence following said curve through a central angle of 6° 15' 51" 174.93 feet.
