Recitals

1. The City of Stevenson is the owner of certain real property located in the City of Stevenson, State of Washington, described as follows:

2. Said real property consists of a way for an alley which has never been developed or improved.

3. Said real property is not necessary to the needs of the City of Stevenson and is surplus and in excess of the foreseeable needs of the City of Stevenson.

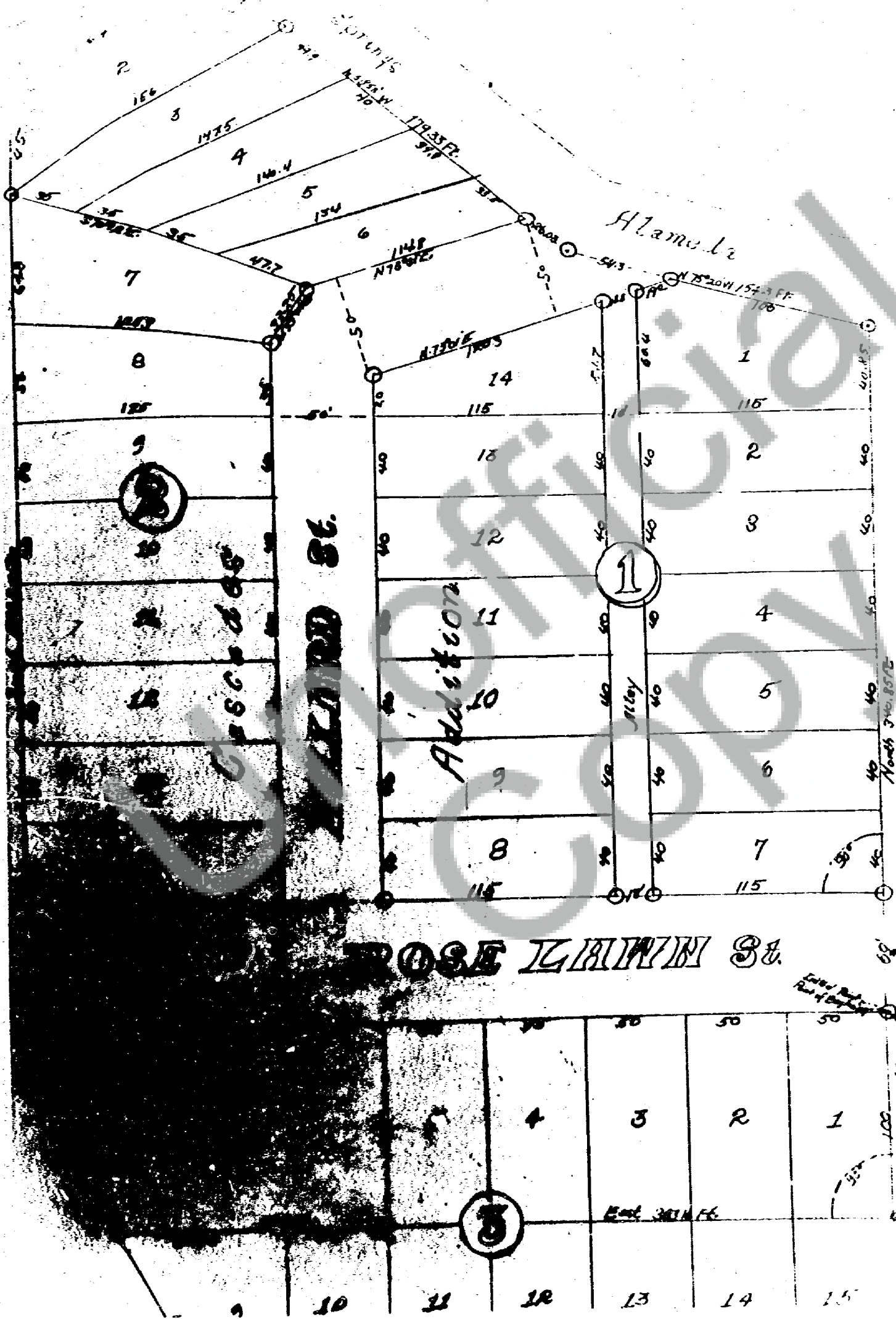
