

PRIVATE ROADWAY AGREEMENT

MEL STEWART SHORT PLAT
as recorded in Book 3, Page 137
of
Skamania County Auditor's Records

WHEREAS, it is the opinion of the undersigned owners of real estate located in Skamania County, Washington, that it will be in their best interest to retain and maintain the access roadways within the boundaries of the above short plat as a private roadway;

THEREFORE, BE IT RESOLVED as follows:

1. That said property owners do retain all roadway areas within said short plat as private roadways;
2. That said property owners shall do all construction and maintenance on all roadways in order to assure a safe roadway condition and assume jointly all and total responsibility for such private roadway areas with cost to be shared equally by the property owners and at no expense to Skamania County;
3. That the type of maintenance required and method of collection and disbursement of funds shall be determined at an annual meeting of landowners of said short plat, to be held at such time and place as shall be agreed upon by the landowners;
4. That assessed costs for road maintenance shall become due and collectable at completion of the work;
5. That such assessments shall be a charge on the land and shall be a continuing lien upon the property against which such assessment is made;
6. That if the property owners of said short plat shall at any time request Skamania County to assume responsibility for the roadway within said short plat, they shall design and construct such roadway system within said short plat to the approved County Road Standards then in effect and dedicate in total such constructed and approved roadway system to Skamania County.
