RELEASE OF EASEMENT

The UNITED STATES OF AMERICA, Bonneville Power Administration, does hereby release and quitclaim unto the underlying fee owners of record, all its right, title, and interest in and to the access roads described below located in the County of Skamania, in the State of Washington, to-wit:

Access Road AFX-11-AR-1, Parcels 1, 3, and 5, Located in the S $\frac{1}{4}$ NW $\frac{1}{4}$ and the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 14 and the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 11, Township 2 North, Range 5 East, Willamette Meridian, Skamania County, Washington, as described in the Contract and Grant of Easement (Access Road), along with other land conveyed, dated March 17, 1981, recorded July 7, 1981, under Auditor's File No. 92733, Deed Records of Skamania County, Washington, and as shown on the attached reduced copy of BPA Drawing No. 40211 marked Exhibit A and by this reference made a part hereof.

Access Road AFX-11-AR-1, Parcel 7, Located in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 11, Township 2 North, Range 5 East, Willamette Meridian, Skamania County, Washington, as described in the Access Road Easement dated July 15, 1980, recorded July 24, 1980, in Book 78, Page 481, Deed Records of Skamania County, Washington, and as shown on the attached reduced copy of BPA Drawing No. 40211 marked Exhibit A and by this reference made a part hereof.

The road parcels herein released are no longer required for access road purposes and are released pursuant to the Acts of August 20, 1937 (50 Stat. 732, 16 U.S.C. § 832a), as amended, and June 30, 1949 (63 Stat. 385, 40 U.S.C. § 484), as amended, and regulations and delegations of authority issued pursuant thereto.

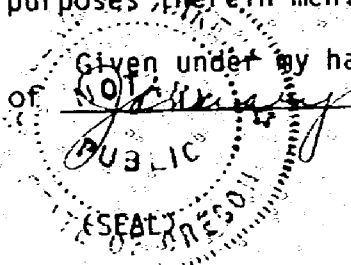

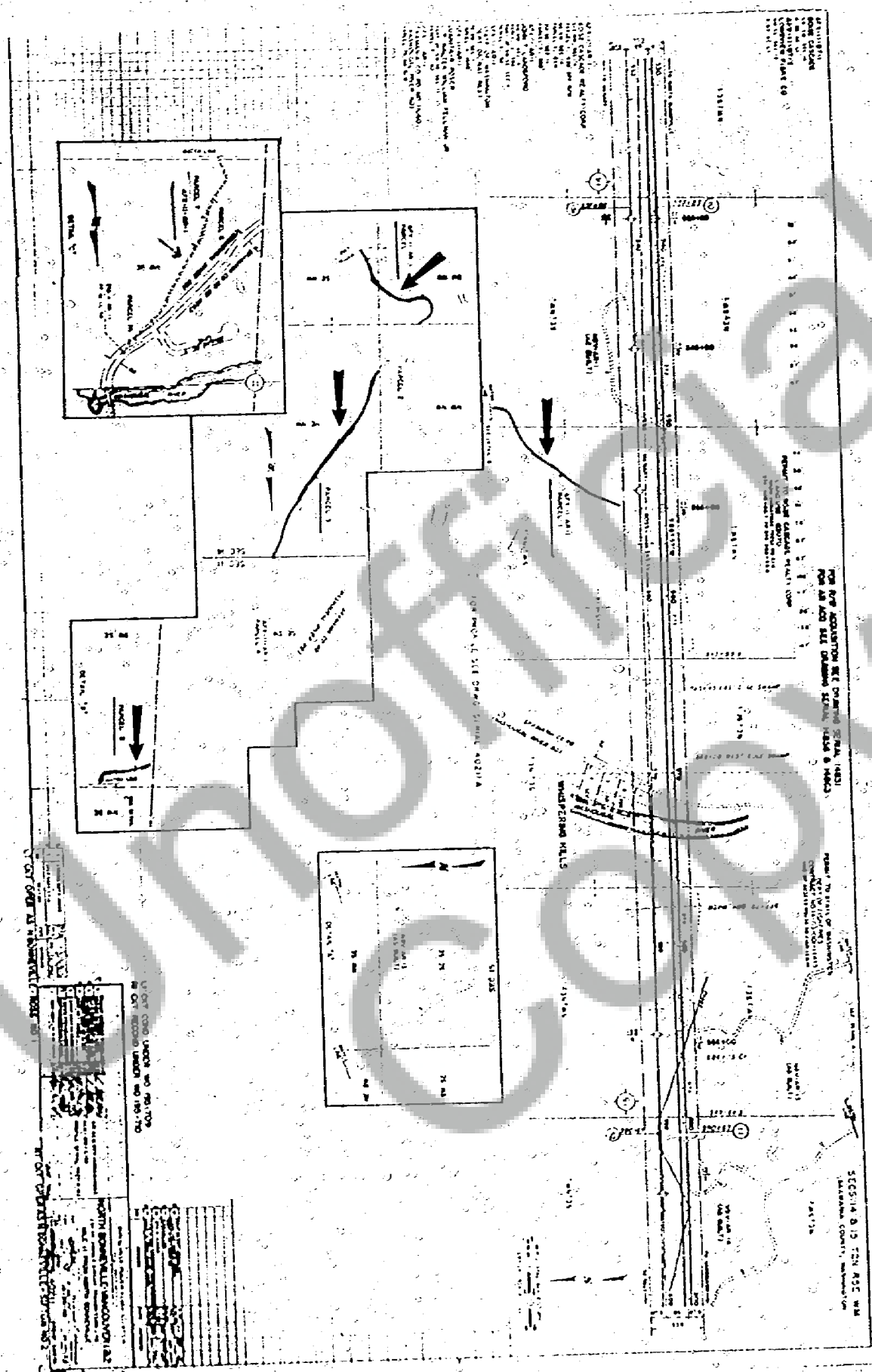
