## ROAD MAINTENANCE AGREEMENT-J. PRICE SHORT PLAT

WHEREAS, the J. PRICE SHORT PLAT, Described as a portion of the SW1/4, Sec. 34, T. 2 N., R. 6 E., and GVT. LOT 2, Sec. 3, T. 1 N., R. 6 E., W.M., created by instrument recorded November 16, 1982, in Book 3, Page 41, Auditors File No. 95010, Skamania County Short Plat Records, includes Lots 1, 2, and 3.

WHEREAS, Lot 1 is owned by A. ELLEN JONES, AND JOAN URBAN, Lot 2 by ERNEST C. CARLSON, DOROTHY FITZGERALD CARLSON, AND ERNEST CONRAD CARLSON, and Lot 3 by JOHN PRICE AND MELISSA CARLSON PRICE. The above named are herein referred to as landowners.

WHEREAS; the Short Plat Agreement includes language as follows: NOTE: Indian Mary private road will be maintained a minimum 16' wide at the proportional expense of road frontage ownership by the property owner(s) having right to use said road.

WHEREAS, the United States of America acting by and through the U.S.D.A., Forest Service, herein called Forest Service, is negotiating to acquire certain lots within the short plat, and will not have cause to use said road for residential purposes. Probable use will be extremely limited and for administrative reasons. THUS assigning a disporportionate burden of road maintenance as currently written. THEREFORE, by this agreement the owners of Lots 1, 2, and 3 agree to amend said language as follows:

NOTE: Indian Mary private road will be maintained a minimum 16' wide at the proportional expense based upon use by the owners having a right to use said road. (The effect of this amendment is intended to change the maintenance arrangement from obligation based on simple frontage ownership to proportional use.)

NOW, THEREFORE, The Landowners, and on behalf of their heirs, assigns, or successors in interest as evidenced by their signature, agree to the amendment as written.
