
NOTICE IS HEREBY GIVEN THAT DON MELTON AND DICK MELTON, dba MELTON BROTHERS EXCAVATING & TRUCKING, of Clark County, State of Washington, claim a lien upon timber manufactured of International Paper Company being about 810,000 board feet in quantity which were cut and/or manufactured in Cowlitz County, State of Washington, are marked ⁿ 24 * or IP also known as ID No. SS-901, and are now lying in Cowlitz County, for labor performed upon and assistance rendered in transporting said timber from cutting to International Paper Company's mill; that the name of the owner or reputed owner is International Paper Company; that International Paper Company employed said Abernathy Tree-O Logging, Inc. to perform contract cutting, logging and transportation assistance, who in turn employed Don Melton and Dick Melton, dba Melton Brothers Excavating & Trucking, to perform such labor and render such assistance upon the following terms and conditions, to wit:

Transportation of logs from cutting/logging site located in Skamania County, Washington site known as Frozen Finger and transporting the same to International Paper Company's mill located in Longview, Cowlitz County, Washington at the rate of \$37.10 per 1,000 board feet.

The said Abernathy Tree-O Logging, Inc. agreed to pay the said Don Melton and Dick Melton, dba Melton Brothers Excavating & Trucking for such labor and assistance bi-weekly; that said contract has been faithfully performed and fully complied with on the part of said Don Melton and Dick Melton, dba Melton Brothers Excavating & Trucking, who performed labor upon and assisted in transportation of 810,000 board feet of timber and/or assorted pulp and paper products; that said labor and assistance were so performed and rendered upon said timber between the 28th day of January, 1989 and the 12th day of April, 1989; and the rendition of said service was continuing on the 12th day of April, 1989, and sixty days have not elapsed since that time; that the amount of claimant's demand for said service is \$30,043.18 plus \$250 attorneys fees, for a total of \$30,293.18; that no part thereof has been paid and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$30,293.18, in which amount Don Melton and Dick Melton, dba Melton Brothers Excavating & Trucking claims a lien on all said timber, logs and/or resulting pulp and paper products owned by said International Paper Company of said county to secure payment for the work and labor performed in obtaining or securing the said logs, spars, piles or other timber, lumber or shingles herein described.
