NOTICE IS HEREBY GIVEN THAT NATHAN MELTON, dba NATHAN MELTON TRUCKING, of Clark County, State of Washington, claims a lien upon logs of Westwood Timber and Menasha Corporation, being about 578,000 lb. in quantity which were cut in Skamania County, State of Washington, are marked <sup>N</sup>16 and <sup>N</sup>46 and are now lying in Longview, Cowlitz County, Washington, for labor performed upon and assistance rendered in transporting said logs; that the name of the owner or reputed owner is Menasha Corporation and/or Westwood Timber Corporation; that Menasha Corporation and Westwood Timber Corporation employed said Abernathy Tree-O Logging, Inc. to perform contract cutting, logging and transportation assistance, who in turn employed Nathan Melton, dba Nathan Melton Trucking to perform such labor and render such assistance upon the following terms and conditions, to wit:

Transportation of logs from cutting/logging site located in Skamania County, Washington to Menasha Corporation/Westwood Timber Corporation's log yard located in Longview, Cowlitz County, Washington at the rate of \$3.35 to \$3.39 per 1,000 lb. of cut logs hauled.

The said Abernathy Tree-O Logging, Inc. agreed to pay the said Nathan Melton, dba Nathan Melton Trucking for such labor and assistance bi-weekly; that said contract has been faithfully performed and fully complied with on the part of said Nathan Melton, dba Nathan Melton

Trucking, who performed labor upon and assisted in transportation of said cut logs; that said labor and assistance was so performed and rendered upon said timber between the 15th day of October, 1988 to, through and including the 22nd day of March, 1989; and the rendition of said service was concluded on the 22nd day of March, 1989, and sixty days have not elapsed since that time; that the amount of claimant's demand for said service is \$19,477.00 plus \$250 attorneys fees, for a total of \$19,727.00; that no part thereof has been paid and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$19,727.00, in which amount Nathan Melton, dba Nathan Melton Trucking claims a lien on all said timber, logs and spars now owned by said Menasha Corporation and Westwood Timber Corporation of said county to secure payment for the work and labor performed in obtaining or securing the said logs, spars, piles or other timber, lumber or shingles herein described.
