

AMENDED
REAL ESTATE MORTGAGE

THE MORTGAGORS, **TIMOTHY L. ASH** and **SHAWNE BORDEAUX ASH**, husband and wife, mortgage to **ROBERT K. LEICK, TRUSTEE OF THE BRENDA BABCOCK TRUST**, to secure the payment of **THIRTY-SIX THOUSAND, FIVE HUNDRED TWENTY-SIX and 21/100 DOLLARS (\$36,526.21)** according to the terms of a promissory note bearing date July 25, 1988, made by the Mortgagors and payable to the order of the Mortgagee, the following described real estate situated in Skamania County, State of Washington, together with all after acquired title therein, and together with all tenements and appurtenances thereto:

Beginning at the northeast corner of Block Eight of the Town of Stevenson, according to the official plat thereof recorded at page 11 of Book A of Plats, records of Skamania County, Washington; thence north 34 deg. 30 min. west 81.2 feet along the westerly line of Russell Avenue to the initial point of the tract of land hereby described; thence north 34 deg. 30 min. west 64 feet; thence south 55 deg. 30 min. west 100 feet; thence south 34 deg. 30 min. east 64 feet; thence north 55 deg. 30 min. east 100 feet to the initial point; said tract being located in Section 1, Township 2 North, Range 7 East of the Willamette Meridian, and in the City of Stevenson.

The Mortgagors promise and agree to pay before delinquency all taxes, liens, special assessments and other public charges levied, assessed or charged against said property and to keep the buildings on the property in good repair and insured against loss or damage by fire in the sum of \$36,530.00, for the benefit of the Mortgagee and to deliver all policies and renewals to the Mortgagee.

In case of failure to perform any of the foregoing covenants, or if default is made in the payment of said note, or any part thereof, when the same shall become due, then this mortgage may be at once foreclosed for the entire principal sum and costs, and in such foreclosure suit there shall be included in the judgment a reasonable sum as attorney's fees, together with all sums paid by the mortgagees or assigns on account of taxes, liens, assessments, abstracts or title insurance charges, costs of searching records, interest, and fire insurance, with
