FIFTH: All of my property and that of my said husband are in joint tenancy in both of our names with the exception of an undivided one-eleventh interest in the estate of my deceased mother, Amanda Williams, still in probate in Clarke County, State of Weshington.

SIXTH: I give and bequeath to my said daughter DAWN C. SCHULTZ all of my jewelry, furs, personal effects and clothing.

SEVENTH: With the consent of my husband endorsed on this Will, I give and bequeath to my said daughter in the event that she should survive me for at least thirty days, ten thousand dollars to be paid to her without interest one year after my death and if not so paid then interest shall be paid to her quarterly thereafter at the rate of seven per cent per annum until the said principal amount has been paid to her.
