## MORTGAGE

GRANT OF MORTGAGE. Application of Proceeds. Grantor shall promptly notify Lender of any loss or damage to the Property if the estimated cost of repair or replacement exceeds \$500.00. Lender may make proof of loss if Grantor fails to do so within lifteen (15) days of the casualty. Whether or not Lender's security is impaired, Lender may, at its election, apply the proceeds to the reduction of the Indebtedness, payment of any lien affecting the Property, or the restoration and repair of the Property. Sale of the Property. To the extent permitted by applicates law, Grantor hereby waives any and all right to have the property marshalled. Notice of Sale. Waiver; Election of Remedica. Attorneys' Fees; Expenses. Annual Reports. If the Property is used for purposes other than Granfor's residence, Granfor shall furnish to Lender, upon request, a statement of net cash profit received from the Property during Granfor's previous fiscal year in such detail as Lender shall require. "Net cash profit" shall mean at cash receipts from the Property Jess all cash expenditures made in connection with the operation of the Property.

Caption Headings. Caption headings in this Mortgage are for convenience purposes only and are not to be used to interpret or define the provisions of this Mortgage.

Merger. There shall be no merger of the interest or estate created by this Mortgage with any other interest or estate in the Property at any time held by or for the benefit of Lender in any capacity, without the written consent of Lender.

Multiple Parties. All obligations of Grantor under this Mortgage shall be joint and several, and all references to Grantor shall mean each and every Grantor. This means that each of the persons signing below is responsible for all obligations in this Mortgage. Severability.
