SCHEDULE "A"

RICHARD S. HASKEW AND MOREEN L. HASKEW
TO
SKAMANIA COUNTY, WASHINGTON

A right-of-way as required for the county road known and designated Duncan Creek Road, County Road No. 10110, located in the east half of the southeast quarter of the southwest quarter (E 1/2, SE 1/4, SW 1/4) and the west half of the southwest quarter of the southeast quarter (W 1/2, SW 1/4, SE 1/4) of Section 28, Township 2 North, Range 6 East, W.M., in Skamania County, Washington.

CENTERLINE DESCRIPTION

Beginning at the Skamania County brass monument marking the south quarter corner of Section 28, Township 2 North, Range 6 East, W.M., thence N89°07'18"W 300.14 feet along section line, thence north 476.25 feet to Engineer's Station 84+00 being the initial point of the centerline herein described, thence N41°46'42"E 57.43 to P.C. Station 84+57.43, being the P.C. of a 150 foot radius curve to the left; thence following said curve through a central angle of 56°58'10" 149.14 feet; thence N15°11'28"W 20.69 feet to P.C. Station 86+27.26, being the P.C. of a 150 foot radius curve to the right; thence following said curve through a central angle of 56°11'11" 147.10 feet; thence N40°59'42"E 152.67 feet to P.C. Station 89+27.03, being to P.C. of a 100 foot radius curve to the left; thence following said curve through a central angle of 37°49'30" 66.01 feet; thence N03°10'13"E 18.74 feet to P.C. Station 90+21.78, being the P.C. of a 100 foot radius curve to the right; thence following said curve through a central angle of 87°06'20" 152.03 feet; thence S89°43'27"E 49.17 feet to P.C. Station 92+22.98, being the P.C. of a 100 foot radius curve to the left; thence following said curve through a central angle of 141°55'47" 247.71 feet; thence N51°39'14"W 79.31 feet to P.O.T. Station 95+50.

RIGHT-OF-WAY DESCRIPTION

A strip of land lying to the right of the above described centerline and being 30 feet in width from Station 84+00 to Station 85+50; thence tapering to 45 feet at Station 86+00; thence 45 feet in width to Station 90+00; thence tapering to 65 feet at Station 90+50; thence 65 feet to Station 93+50; thence tapering to 30 feet in width at Station 94+00; thence 30 feet to Station 95+50.

Also a strip of land lying to the left of the above described centerline and being 50 feet in width of Station 91+50; thence tapering to 30 feet in width at Station 92+00; thence 30 feet in width to Station 95+50.

All that portion lying within the grantor's real property as described in warranty deed dated October 11, 1965 and recorded in Book 55, Page 103, Auditor's Book of Deeds, Skamania County, Washington.

Containing a total area of 1.65 acres and being a net additional right-of-way of 0.63 acres more or less.


