EASEMENT Dated: June 30, 1989

In consideration of the sum of \$10.00, receipt of which is hereby acknowledged, Central Catholic High School, an Oregon non-profit organization ("Grantor"), conveys to Remy W. Fulsher and Barbara F. Fulsher, their heirs, successors and assigns ("Grantee"), a perpetual nonexclusive easement to use a strip of land 60 feet wide, located as follows across the property of Grantor in Skamania County, Washington:

1. Grantees, their agents, independent contractors and invitees shall use the easement strip for road and utility purposes only for access to the property described in paragraph 7 and in conjunction with such use may construct, reconstruct, maintain and repair a road thereon.

Such amendment of the description shall be effective whether or not signed by Grantees, but Grantees shall execute it or such other document necessary to indicate relocation of the easement strip when and if requested by Grantor.
