REAL ESTATE CONTRACT

THIS CONTRACT, made and entered into this 121st day. OF August , 1989 between DENNIS A. PETERSON and CATRERINE V. PETERSON, husband and wife, hereinafter called the "seller," and JEFFREY L. HULL and LUCINDA M. HULL, husband and wife, hereinafter called the "purchaser,"

WITNESSETH: That the seller agrees to sell to the purchaser and the purchaser agrees to purchase from the seller the following described real estate, with the appurtenances, in Skamania County, State of Washington:

The terms and conditions of this contract are as follows: The purchase price is Forty-Six Thousand Dollars (\$46,000.00) of which Four Thousand Six Hundred Dollars (\$47,600.00) have been paid, the receipt whereof is hereby acknowledged and the balance of said purchase price shall be paid as follows: Three Hundred and Seventy-Two and 49/00 Dollars (\$372.49) or more at purchaser's option, on or before the 20th day of September, 1989 or before the 20th day of each succeeding calendar month until the purchaser further agrees to pay interest on the diminishing per annum from the 1st day of August 1989 which balance of each payment applied in reduction of principal.

All payments to be made hereunder shall be made at or mailed to the sellers at P.O. Box 113, Stevenson, Washington 98648 or at such other place as the seller may direct in writing.

As referred to in this contract, "date of closing" shall be

(1) The purchaser assumes and agrees to pay before delinquency all taxes and assessments that may be as between grantor and grantee hereafter become a lien on said real estate; and if by the terms of this contract the purchaser has assumed

payment of any mortgage; contract or other encumbrance, or has assumed payment of or agreed to purchaser subject to, any taxes or assessments now a lien on said real estate, the purchaser agrees to pay the same before delinquency. Taxes for the year 1989 shall be prorated as of the date of possession.

- (2) The purchaser agrees, until the purchaser price is fully paid, to keep the buildings now and hereafter placed on said real estate insured to the actual cash value thereof against loss or damage by both fire and windstorm in a company acceptable to the seller and for the seller's benefit, as his interest may policies and renewals thereof to the seller. - (4) The purchaser assumes all hazards of damage to of destruction of any improvements now on said real estate or hereafter placed thereon and of the taking of said real estate or any part thereof for public use; and agrees that no such damage, consideration or taking shall constitute a failure of for public use, the portion of the condemnation award remaining after payment of reasonable expenses of procuring the same shall be paid to the seller and applied as payment on the purchaser apply all or a portion of such condemnation award to the rebuilding or restoration of any improvements damaged by such taking. - (5) The seller has delivered, or agrees to deliver within 15 days of the date of closing, a purchaser's policy of title insurance in standard form, or a commitment therefor, issued by a licensed title insurance company, insuring the purchaser to the full amount of said purchase price against loss or damage by

- c. Any existing contract or contracts under which seller is purchasing said real estate, and any mortgage or other obligation, which seller by this contract agrees to pay, none of which for the purpose of this paragraph (5) shall be deemed defects in seller's title.
- (6) If seller's title to said real estate is subject to an existing contract or contracts under which seller is purchasing said real estate, or any mortgage or other obligation which sellers is to pay, seller agrees to make such payments in accordance with the terms thereof, and upon default, the remove the default, and any payments so made shall be applied to the payments next falling due the seller under this contract.
- (7) The seller agrees, upon receiving full payment of the purchase price and interest in the manner above specified, to execute and deliver to purchaser a statutory warranty deed to said real estate, excepting any part thereof hereafter taken for public use, free of encumbrances except any that may attach after date of closing through any person other than the seller, and subject to the following easements and restrictions of record:

This contract is not assignable without written permission of the seller, but permission will not be unreasonably withheld. Deed release to the unimproved lots will be furnished by seller upon payment of \$5,000.00 for each of said lots but will be furnished only if the contract payments are current when deeds are requested and paid for.

(8) Unless a different date is provided for herein, the purchaser shall be entitled to possession of said real estate on not in default hereunder. The purchaser covenants to keep the buildings and other improvements on said real estate in good of, the real estate for any illegal purpose. - If the seller shall bring suit to procure an adjudication of the termination of the purchaser's rights hereunder, and judgment is so entered, the purchaser agrees to pay a reasonable sum as such suit, and also the reasonable cost of searching records to determine the condition of title at the date such suit is commenced, which sums shall be included in any judgment or decree
