1. History of Corner Establishment and Subsequent Restoration:

This corner was established by N.W. Pettijohn in 1957, while performing a survey for PACIFIC POWER AND LIGHT CO., when surveying the limits of Swift Reservoir. The concrete monument shown in the diagram below was set at that time. The corner has been used by various surveyors since that time for various projects. On August 16, 1988, R. Bogdon (from HAMPSTUR CORP.), found and referenced the corner while working on a "corner restoration" project for PLUM CREEK TIMBER COMPANY, under the direction of C. Hampton, PLS #18,087. Refer to the diagram below for references made at that time.

2. Description of Evidence Found:

Found the 3" brass cap in 8" dia. concrete monument, set flush to the ground, as set in 1957, as noted above and shown below.

Found no RP's.
