1. History of Corner Establishment and Subsequent Restoration:

In 1977, Hagedorn, Inc. set a rebar and plastic cap for this corner during a survey as recorded in Book 1 of Surveys, at Page 142. Then in 1985, Hagedorn, Inc. remonumented the corner with a USFS 2 1/2" aluminum monument and additional references were made as indicated on his record of survey recorded in Book 2 of Surveys, at Page 236. On July 27, 1988, R. Bogdon (from HAMPSTUR CORP.), located the above corner and refreshed the references and added the steel reference post shown in the diagram below, while working on a "corner restoration" project for PLUM CREEK TIMBER COMPANY, under the direction of C. Hampton, LS #18,087.

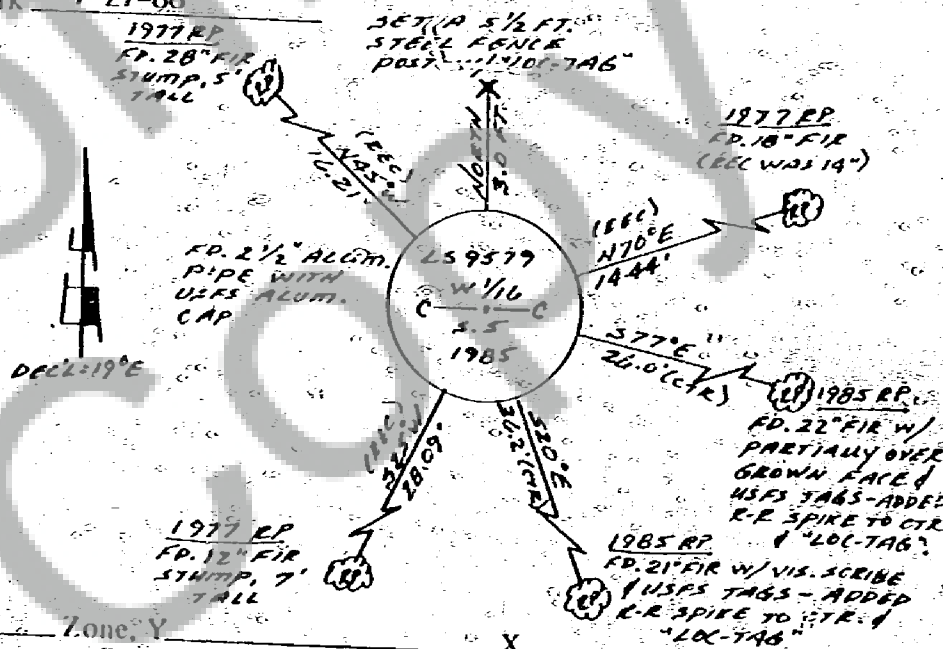
2. Description of Evidence Found:

Found the 2 1/2" aluminum USFS monument as set in 1985, mentioned above and shown below, along with 5 RP's, as shown in the diagram below.

3. Describe Monument, Accessories and Corollary Data to Perpetuate this Corner Location. Diagram corner and indicate meridian and reference to map of record. Surveyor's Field Book No. PS-056 Page No. 19 Date of work 7-27-88

LOCATION:

- at the NE corner of a stand of mature conifers;
- on a South slope, approx. 100 ft. North of a basin.
- 125 ft. East of a 30 ft. ravine, which bears to the Southeast.
- approx. 150 ft. West of a gentle ridge, which bears Southeast.
- approx. 275 ft. South of a logging road, which bears S45°W & N52°E; at a point which is 10 ft. West of a spur road to the North.
