1. History of Corner Establishment and Subsequent Restoration:

This corner was originally a 15"x12"x6" boulder, as set in 1909 by C.F. Rhodes under GLO contract #674. Then in 1984, B.L. Jones, LS #18,734, remonumented the corner with a standard 2 1/2" USFS Aluminum mon. and added additional references while under a USFS contract. Then on August 17, 1988, R. Bogdon, (from HAMPSTUR CORP.), located the above corner and refreshed the RP's and added a steel reference post as indicated in the diagram below, while working on a "corner restoration" project for PLUM CREEK TIMBER COMPANY, under the direction of C. Hampton, PLS #18,087.

2. Description of Evidence Found:

1909 GLO MONUMENT: found the aluminum monument set in 1984 in place of the original stone, as mentioned above and shown in the diagram below.

ORIGINAL GLO BT's:

-50" Fir, S130E--28 lks.; found a 56" live tree, with over grown face--see diagram.
-38" Fir, N640W--25 lks.; found a 40" Fir snag, 50 ft. high--see diagram below.

SUBSEQUENT RESTORATION:

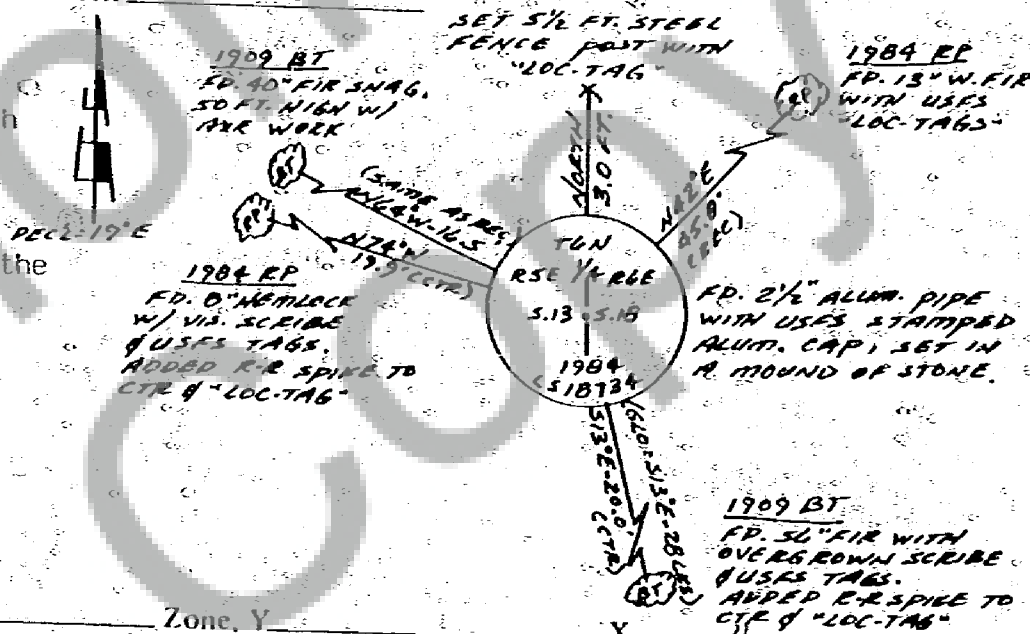
Found the aluminum monument as set in 1984 along with 2 references, as mentioned above and shown in the diagram below.
