property.

2. That upon the death of GEORGE LESTER COOK all of his  
interest in all community property shall immediately vest in

3. That upon the death of THERESE CECILE COOK, all of  
her interest in all community property shall immediately vest in  
GEORGE LESTER COOK.

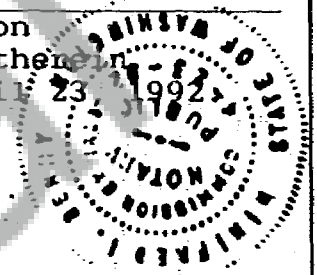
