3. The parties to the Agreement were legally competent at the time of the Agreement and executed no subsequent Wills or agreements which would have the effect of abrogating or nullifying the Agreement.

Parcel 1: A tract of land located in the east ten (10) acres of Lot 2 of Oregon Lumber Company's Subdivision in Section 14, Township 3 North, Range 9 E.W.M., according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, Washington, described as follows: Beginning at the Southwest cor-

ner of the East ten (10) acres of Lot 2 aforesaid; thence East along the South line thereof 188 feet to the initial point of the tract hereby described; thence East along said South line 100 feet; thence North 150 feet; thence West 100 feet; thence South 150 feet to the point of beginning.

Parcel 2: The east 10 acres of Lot 2 of OREGON LUMBER COMPANY'S SUBDIVISION in Section 14, Township 3 North, Range 9 E.W.M. according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, Washington;

SUBJECT to an easement and right of way for an electric power transmission line granted to Skamania County Public Utility District by deed dated June 20, 1941.

Parcel 3: The West Half (W2) of Lot 1 of OREGON LUMBER COMPANY'S SUBDIVISION in Section 14, Township 3 North, Range 9 E.W.M., according to the official plat thereof on file and of record at Page 29 of Book A of Plats, records of Skamania County, Washington;

TOGETHER WITH all water rights appurtenant thereto including the water right described in Certificate of Water Right No. 2048 dated September 22, 1933, and recorded at page 169 of Book G of Miscellaneous Records, records of Skamania County, Washington.

SUBJECT TO easements and rights of way of record for the public road known and designated as the Cooks-Underwood Road.

5. All obligations of the community composed of the decedent and the affiant owing at the date of the decedent's death have been paid in full or otherwise provided for, and the expenses of last illness and for funeral and burial services of the decedent have been paid or likewise provided for.

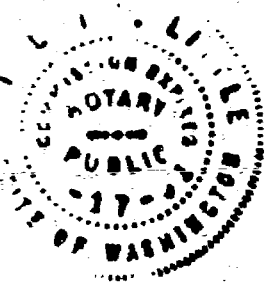
6. There were no estate taxes due as a result of VERA E. ROGERS' demise.
