Dear Sir:

I wish to file a Water Right Claim to receive a registration Number to be used at a later date, if need be.

The Spring I wish to file on belongs to Mr. Clell Thomas, he purchased the spring from a Mr. Franklin, sometime ago. This spring has served the people in this area on Little Street since 1947 that I know of for sure; how long before that I do not know for sure but I don't think it could be less than 10 years.

All the users of the water system pay Mr. Thomas a fee which is fine and right. I am the oldest user of the spring left on this street.

My concern is that at sometime in the future Mr. Thomas may sell the water system as there has been talk of this and there are a few here that if they bought it they would cut the rest of the people off and they would have to drill a well, which some cannot afford to do, as they are on a pension.

Also Mr. Thomas is getting along in years and could pass away, then no one could tell what would happen, I want to protect my right to the use of the spring, if at all possible.

I have been informed that I can do this. Please let me know if this right.

MAC 502-12-090 reads as follows: "Permits secured through this office (Department of Ecology) do not carry any right-of-way privileges. Right-of-way for transmission facilities must be obtained by the permittee from the owner of the property on which such structure (yarn) will be located."

The utilization of water other than your own must be done through agreement and right-of-way gained from the owner of the land upon which the well is located. Failure to secure right-of-way from the owner could deprive you of water in the future.
