

MORTGAGE

THE MORTGAGORS, BRUCE G. TILDEN and NANCY W. TILDEN, husband and wife, hereinafter called the "Mortgagors", mortgage to BRUCE E. TILDEN, hereinafter called the "Mortgagee", the following described real property situated in the County of Skamania, State of Washington, to-wit:

together with the appurtenances, and all awnings, screens, mantels, and all plumbing, lighting, heating, cooling, ventilating, elevating and watering apparatus and fixtures now or hereafter belonging to or used in connection with the property, all of which shall be construed as a part of the realty.

To secure the performance of the covenants and agreement hereinafter contained, and the payment of \$15,500.00.

The Mortgagors covenant and agree with the Mortgagee as follows: That they are lawfully seized of the property in fee simple and have good right to mortgage and convey it; that the property is free from all liens and encumbrances of every kind except as herein set forth; that they will keep the property free from any other encumbrances prior to this mortgage; that they will pay all taxes and assessments levied or imposed on the property and/or on this mortgage or the debt hereby secured; that they will not permit waste of the property; that they will keep all buildings now or hereafter placed on the property in good order and repair and unceasingly insured to the full insurable value thereof.

Should the Mortgagors default in any of the foregoing covenants or agreements, then the Mortgagee may perform the same and may pay any part or all of principal and interest of any prior encumbrance or of insurance premiums or other charges secured hereby, and any amount so paid, with interest thereon at the highest legal rate from date of payment shall be repayable by the Mortgagors on demand, and shall also be secured by this mortgage without waiver of any right or other remedy arising from breach of any of the covenants hereof. The Mortgagee shall be the sole judge of the validity of any tax, assessment or lien asserted against the property, and payment thereof by the Mortgagee shall establish the right to recover the amount so paid with interest.

Time is of the essence hereof, and if default be made in the payment of any of the sums hereby secured, or in the performance of any of the covenants or agreements herein contained, then in any such case the remainder of unpaid principal, with accrued interest and all other indebtedness hereby secured, shall at the election of the Mortgagee become immediately due without notice, and this mortgage may be foreclosed.

In any action to foreclose this mortgage or to collect any charge growing out of the debt hereby secured, or in any suit which the mortgage may be obligated to defend to protect the unimpaired priority of the lien hereof, the Mortgagors agree to pay a reasonable sum as attorney's fees and all costs and expenses in connection with such suit, and also the reasonable cost of searching records, which sums shall be secured hereby and included in any decree of foreclosure.
