### Statutory Warranty Deed

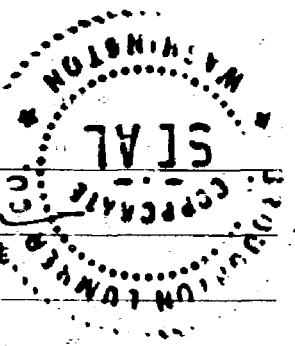
