

FULL RECONVEYANCE

Beginning at the Southwest corner of the Southeast Quarter of Section 17, Township 3 North, Range 8 East of the Willamette Meridian; thence North 30 feet; thence East 30 feet; thence North 1, 143.8 feet to the initial point of the tract hereby described; thence East 208.5 feet; thence North 104.25 feet; thence West 208.5 feet; thence South 104.25 feet to the initial point.

PARCEL B

Beginning at the Southwest corner of the Southeast Quarter of Section 17, Township 3 North, Range 8 East of the Willamette Meridian; thence North 30 feet; thence East 30 feet; thence North 935.3 feet to the initial point of the tract hereby described; thence East 208.5 feet; thence North 208.5 feet; thence West 208.5 feet; thence South 208.5 feet to the initial point.

PARCEL C

Beginning at the Southwest corner of the Southeast quarter of Section 17, Township 3 North, Range 8 East of the Willamette Meridian; thence North 30 feet; thence East 30 feet; thence North 1,248.05 feet; thence East 208.5 feet to the initial point of the tract hereby described; thence East 208.5 feet; thence South 307.75 feet; thence West 208.5 feet; thence North 307.75 feet to the initial point.
