LIMITED POWER OF ATTORNEY

The undersigned gives to said attorney-in-fact full power and authority to execute such instruments as if the undersigned were personally present, hereby ratifying and confirming all that said attorney-in-fact shall lawfully do or cause to be done by authority hereof. This limited power of attorney has been executed and is effective as of this 27th day of December 1989, and the same shall continue in full force and effect until revoked in writing by the undersigned.
