intervention powers has been filed.

4. Petitioner is the person who has been confirmed as the personal representative of the decedent's estate and has been qualified as such and said estate qualifies to be settled and administered without the intervention of any court pursuant to Chapter 11.68 of the Revised Code of Washington.

Based upon the foregoing, is it is hereby

ORDERED, ADJUDGED AND DECREED that the petitioner, VERNE PETER TOL, who is the personal representative of the above entitled estate, is authorized to administer and close said estate without further intervention or supervision as provided by Chapter 11.68, Revised Code of Washington; and it is finally

ORDERED that the petitioner, VERNE PETER TOL, as personal representative of the above entitled estate, is authorized to transfer without further order of this court, all assets of the estate, whether real property, personal property, or mixed, and/or to make distribution thereof in accordance with the order of heirship above referenced.
