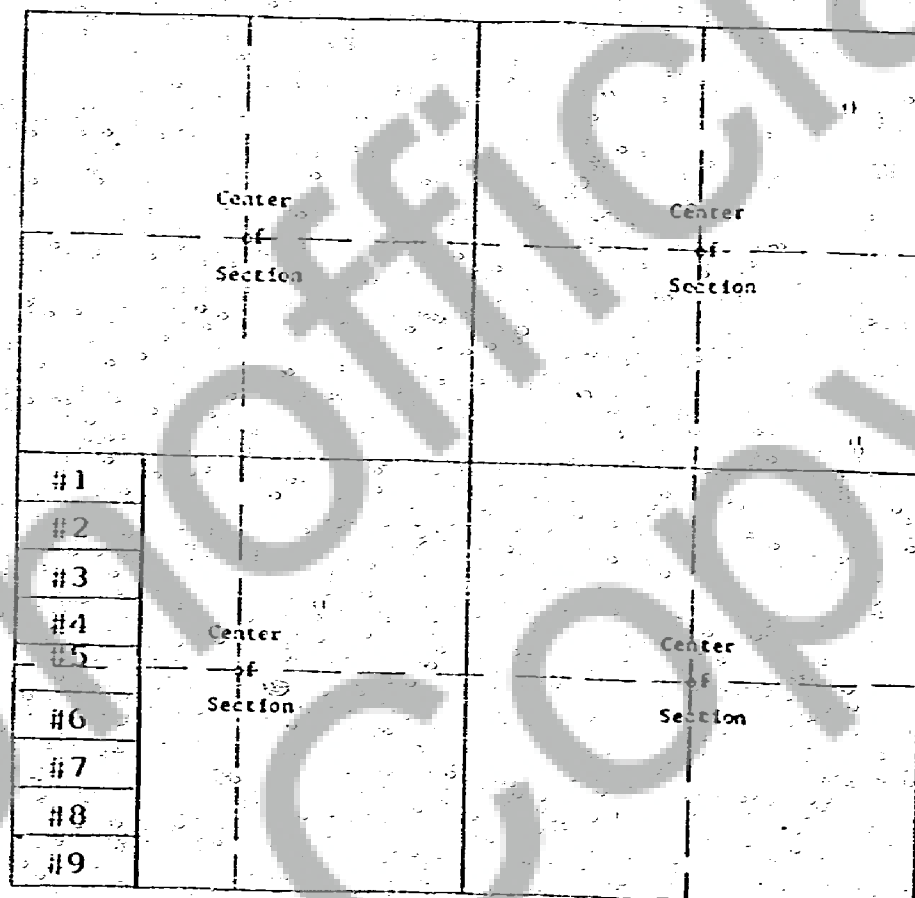
SHOW SITE OF CLAIM
