AFFIDAVIT IN SUPPORT OF COMMUNITY PROPERTY AGREEMENT

DOROTHY D. MENIG, being first duly sworn, on oath, deposes and says:

1. This affidavit is for the purpose of supplying information for record pertaining to that certain Community Property Agreement executed by ROBERT EARL MENIG and DOROTHY D. MENIG, husband and wife, which Agreement was dated January 22, 1979, and also for the estate of Robert Earl Menig, deceased, one of the parties to said Agreement. It is intended that the statements set forth herein shall be considered representations of fact which may be relied upon by all parties dealing with the personal property and the real estate described on Exhibit "A" attached and made a part hereof.

2. Robert Earl Menig died on March 22, 1990 at Skyline Hospital, White Salmon, Klickitat County, Washington.

3. The parties to the Community Property Agreement referred to above entered into no subsequent Wills or Agreements which would have the effect of abrogating or nullifying the above-mentioned Community Property Agreement. A copy of said Community Property Agreement is attached hereto as Exhibit "B".

4. The decedent left no separate estate.

5. All obligations of the community owing at the date of death of decedent have been paid in full or provided for, and all expenses of last illness and for funeral and burial services have been paid.

Beginning at a point 50 feet west and 40 feet south of the northwest corner of the Northeast Quarter (NE $\frac{1}{4}$) of Section 29, Township 3 North, Range 8 E.W.M.; thence east 250 feet; thence south 418 feet; thence west 180 feet; thence in a northerly direction along the county road to a point 250 feet west and directly south of the point of beginning; thence north to the point of beginning;

TOGETHER WITH all water rights appurtenant thereto.

2. The following described real estate, situated in the County of Skamania, State of Washington:

Lot 2 of the Wallace Newman Short Plat.

More particularly described:

A tract of land in the Northwest quarter of the Northeast quarter (NW $\frac{1}{4}$, NE $\frac{1}{4}$) of Section 29, Township 3 North, Range 8 East W.M., more particularly described:

Beginning at the quarter corner on the north line of Section 29, T 3 N, R 8 E.W.M.; thence east along the north line of said Section 29 to a point 1050 feet west of the northeast corner of the northwest quarter of the northeast quarter of the said Section 29; thence south 219 feet; thence east 15 feet; thence south 260 feet more or less to the northerly line of that County Road known as and

designated Carson Creek Road (Co. Rd. No. 20450); thence west following the northerly line of said County Road 100 feet more or less to the southeast corner of the tract of land conveyed to Clifford M. Dillingham by deed dated June 15, 1934, and records at Page 431 of Book Y of Deeds, Records of Skamania County, Washington; thence north 418 feet to the northeast corner of Dillingham Tract; thence west 200 feet; thence north 40 feet to the point of beginning.

TOGETHER WITH an easement including the terms, covenants and provisions thereof, as disclosed by instrument recorded October 19, 1961 under Skamania County Auditor's File No. 59068 in Book 49 at Page 228 for water rights and existing water pipe line easements.

SUBJECT TO an easement including the terms, covenants and provisions thereof, as conveyed by instrument recorded February 9, 1977 under Skamania County Auditor's File No. 83569 in Book 72 at Page 245 in favor of Skamania County, Washington for right of way for county road designated Carson Creek Road #20450.

EXHIBIT "B"

COMMUNITY PROPERTY AGREEMENT

This Community Property Agreement entered into this date by and between ROBERT EARL MENIG and DOROTHY D. MENIG, husband and wife, both of Carson, County of Skamania, State of Washington:

W I T N E S S E T H:

WHEREAS, the parties hereto are the owners of certain real and personal property situate in the State of Washington; and

WHEREAS, it is contemplated by the parties hereto that they may acquire additional property in the future; and

WHEREAS, it is the desire hereto that all of their property shall pass to the survivor without delay or expense in the event of the death of either party;

NOW, THEREFORE, we, ROBERT EARL MENIG and DOROTHY D. MENIG, for and in consideration of the love and affection which we have one for the other, do hereby mutually agree that all of the property which we now own separately, jointly or otherwise and whether real, personal or otherwise, and wheresoever situate, shall be and it is hereby declared to be the community property of the parties, and each of the parties to this agreement does hereby convey and transfer to the other party and to the community, all property owned by them, even though the same be held in his or her separate estate; and

We hereby mutually agree that all of the property which shall hereafter be acquired by either of us, whether separately, jointly or otherwise, and of whatsoever nature and wheresoever situate, shall be and it is hereby declared to be community property, and each of the parties does hereby convey and trans-

fer to the other and to the community all such property hereafter acquired by either of them, even though the same be acquired in his or her separate estate, and

IT IS FURTHER AGREED that the whole of the community property now owned by us or hereafter acquired by us, including all property the status of which is changed or created by this agreement, shall at once, in the event of the death of ROBERT EARL MENIG while the said DOROTHY D. MENIG survives, be vested in DOROTHY D. MENIG absolutely and in fee simple as her sole and separate property; and in the event of the death of the said DOROTHY D. MENIG while the said ROBERT EARL MENIG survives, then the whole of the community property now owned by us or hereafter acquired by us, including all property the status of which is changed or created by this agreement, shall at once vest in the said ROBERT EARL MENIG absolutely and in fee simple as his sole and separate property.
