QUIT CLAIM DEED

THE GRANTORS, HEGEWALD TIMBER COMPANY, INC. a corporation, and
R. M. HEGEWALD and HELEN HEGEWALD, husband and wife, by way of
gift, do hereby convey and quit claim to SKAMANIA COUNTY, a
Political Subdivision of the State of Washington, all of said
Grantors' interest in and to the following described real property
situated in the County of Skamania, State of Washington, together
with any and all after acquired title of the grantor therein:

Beginning at the point of intersection of the north
line of the Baughman D.L.C. in Section 1, Township
2 North, Range 7 E.W.M., with the easterly boundary
line of former State Highway No. 8 according to the
survey approved March 16, 1937, (but now county
road); thence northerly along the easterly line of
said highway a distance of 105 feet; thence east 50
feet; thence south to the north line of the Baughman
D.L.C.; thence west to the point of beginning;

TOGETHER WITH the right of ingress and egress to the
above described real property over flooded proper-
ties formerly owned by Edward Fields and Jessie
Fields, husband and wife, said rights being describ-
ed in deed dated May 19, 1941, and recorded at page
325 of Book 28 of Deeds.

Beginning at a point on the south line of Government
Lot 8, a distance of 300 feet west of the Southeast
corner of said Government Lot 8 in Section 1, Town-
ship 2 North, Range 7, East of the Willamette Meri-
dian; thence west along the south line of said Gov-
ernment Lot 8, 815 feet more or less to the easterly
right of way line of the Old State Road No. 8;
thence northeasterly along said right of way line to
a point due north and 747.8 feet from the point of
beginning; thence due south a distance of 747.8 feet
to the point of beginning.

Skamania County, Washington.

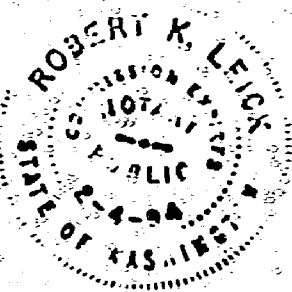
