TRAVERSE STATEMENT: An open traverse of the N-S centerline of Section 14 was made with a Pentax PX10D total station last calibrated in June 1989, with a loop made to the NW and W $\frac{1}{2}$  corners. Closure of the N-S centerline made to Reference 1, for a calculated error of 0.81 ft, for an error of closure of 1:6200. Closure of the closed loop was in excess of 1:10000.

Set IR with plastic cap for W.C. to true C-N 1/16. W.C. bears N 00° 15' 36" E, 220.00 feet from true corner.
