That portion of the East half of the Southeast quarter of Section 16, Township 3 North, Range 10 East of the Willamette Meridian, lying Northerly of the County Road #3041 designated as the Cooks-Underwood Hwy, described as follows: Beginning at the Southwest corner of the East half of the Southeast quarter of the Southeast quarter of the said Section 16; thence North along the West line of said Subdivision 475 feet to the initial point of the tract hereby described; thence North along said line 663 feet; thence South 40°45' East 753 feet to the Northwesterly right of way line of said Cooks-Underwood Highway; thence South 51°30' West along said Northwesterly right of way line 436 feet; thence North 40°30' West 236 feet, more or less, to the initial point; or less.
