

COMMUNITY PROPERTY AGREEMENT

THIS AGREEMENT is made and entered into this 25th day of June, 1990 by and between Robert W. Harmsen and Sharon S. Harmsen, husband and wife, pursuant to the statutes of the state of Washington in such case made and provided, for the purpose of establishing the status of all property owned by the parties upon the demise of either;

NOW, THEREFORE, in consideration of the promises of each to the other, and also in consideration of the love and affection that each bears to the other, it is hereby mutually agreed;

That all property, real, personal and mixed, of whatsoever kind or nature, owned by the parties, or to which they may be entitled, and whether originally acquired as separate property or community property, and all property hereafter acquired by the parties in any manner whatsoever, is hereby declared henceforth to be community property owned entirely by the community composed of these parties, and it is agreed that neither party shall hereafter own any separate property or separate interest in any property of whatsoever kind or nature.

That in the event of the death of said Robert W. Harmsen while the said Sharon S. Harmsen survives, then the whole of all property, of every kind, nature or description, now owned or hereafter to be acquired by the parties, shall at once vest in the said Sharon S. Harmsen in fee simple.

That in the event of the death of said Sharon S. Harmsen while the said Robert W. Harmsen survives, then the whole of all property, of every kind, nature or description, now owned or hereafter to be acquired by the parties, shall at once vest in the said Robert W. Harmsen in fee simple.
