


Land within this subdivision shall not be further subdivided for a period of 5 years unless a final plat is filed pursuant to Skamania County Code, Title 17, Subdivisions, Chapter 17.04 through 17.60 inclusive.

TRAVERSE STATEMENT: Survey utilizing a closed loop to major control points, with side ties to secondary points, conducted between January 14th and March 3, 1986. Angular error of less than 3" per setup and a distance error of 0.08 feet were balanced by compass adjustment for a calculated error of closure in excess of 1:40000. Project was put on hold by client until 1990, when some lot revisions were indicated. Using some old control and established corners, adjusted lot corners were set on March 1, 1990.

NARRATIVE: A closed loop traverse with a Pentax PX-100 total station was conducted during January-March, 1986, with some revised lot corners established in March, 1990. Coordinates from References 1 & 2 were used for basis of bearings. The project included extensive mapping of features, improvements and water surface elevations. An exception for a private cemetery was also marked, determined from information obtained at the County Historical Society.

A portion of the IOOF cemetery was deeded off in 1944. An iron pipe found near the P.O.B. of the cemetery description was not accepted, and an iron rod near the SE cemetery corner, not of record, also was not accepted. New monuments were set for these corners, which creates a line extremely close to the most easterly row of plots. According to cemetery records, Plot 115 is shown as having been used for burial, but no definite determination was made known to me.

Lot acreages were computed for actual land area and to the measured water line.
