The Grantor, CROWN ZELLERBACH CORPORATION, a Nevada corporation, for valuable consideration received, does hereby sell and convey unto the STATE OF WASHINGTON, by and through its State Patrol, Grantee, and its successors in interest, a permanent, nonexclusive easement for the use of a road upon, over and across portions of the SE $\frac{1}{4}$  of Section 4, the W $\frac{1}{2}$  and the S $\frac{1}{2}$  of the SE $\frac{1}{4}$  of Section 10, the W $\frac{1}{2}$  of the W $\frac{1}{2}$  of Section 14, the E $\frac{1}{2}$  of the E $\frac{1}{2}$  of Section 15 and the W $\frac{1}{2}$  of the NW $\frac{1}{4}$  of Section 23, T2N, R6E of the W.M., Skamania County, Washington.

Said road shall be used by Grantee solely and only as an access road for purposes related to the construction, maintenance and operation of its microwave station tower site located in the SE $\frac{1}{4}$  of said Section 4, T2N, R6E, W.M.

The Grantor reserves the right to use the above described property for road use in common with the Grantee, and to grant rights thereupon to others, and reserves rights of entrances, crossings and exits. The grantee has no rights to grant such use to others, except successors in interest of Grantee's property as above described. However, each party using said road or easement shall pay a fair share of the costs of maintenance of the same in proportion to its use thereof.

The terms, conditions, and covenants herein shall extend to and be binding upon and inure to the benefit of the successors and assigns of the parties hereto, as limited hereinabove.
