ORDER NO. SK-12179

A PORTION OF THE WEST HALF OF THE SOUTHWEST QUARTER OF SECTION 5, TOWNSHIP 1 NORTH, RANGE 5 EAST OF THE WILLAMETTE MERIDIAN, SKAMANIA COUNTY, DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF SAID SOUTHWEST QUARTER; THENCE NORTH  $00^{\circ} 46' 52''$  EAST ALONG THE WEST LINE OF SAID SOUTHWEST QUARTER 834.82 FEET TO THE TRUE POINT OF BEGINNING; THENCE NORTH  $00^{\circ} 46' 52''$  EAST ALONG SAID WEST LINE 330 FEET; THENCE SOUTH  $89^{\circ} 13' 08''$  EAST 660 FEET; THENCE SOUTH  $00^{\circ} 46' 52''$  WEST PARALLEL WITH SAID WEST LINE 330 FEET; C THENCE NORTH  $89^{\circ} 13' 08''$  WEST 660 FEET TO THE TRUE POINT OF BEGINNING;

TOGETHER WITH A 60 FOOT EASEMENT, THE CENTERLINE OF WHICH IS DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE NORTH RIGHT OF WAY LINE OF THE BELLE CENTER ROAD WHICH POINT IS SOUTH  $89^{\circ} 13' 08''$  EAST 660 FEET FROM THE WEST LINE OF SAID SOUTHWEST QUARTER; THENCE NORTH  $00^{\circ} 46' 52''$  EAST PARALLEL WITH SAID WEST LINE 867.22 FEET; THENCE NORTH  $89^{\circ} 13' 08''$  WEST 660 FEET TO THE WEST LINE OF SAID SOUTHWEST QUARTER.
