I would like to file a complaint against Skamania County Task Force for the FT. My car was seized by them on March 13, 1990, it had ski racks on top and a radar detector and other personal things inside (including about Thirty Five dollars in change) My car was in Skamania County impounded until June 18th 1990 then moved to Clark county.

Clark county D.A. Melnick said I could have my things from the car. When I found the car I went to get my things. The radar detector and ski racks were not there. I asked the officer that drove the car to Clark County about them, he said they were not there. I told him they were in the car when they took it on March 13, I showed him the entry case for the radar detector and I showed him the marks on the windows where the radar detector was mounted. Then I talked to Skamania County Deputy Warren about the items, he said the car was kept at the impound lot. He also said he saw the suction marks on the roof of the car where the ski racks were mounted.

After telling Deputy Warren I was going to file a complaint he said I will be paid for the ski racks but he would not verify that the radar detector was in the car. He said the car may have been messed with in the impound lot. The car was

The ski racks were also locked and I had a spare key in the car. Warren was calm and nice until I told him I wanted to file a complaint. Then he lost his temper and started yelling "I don't feel sorry for any property you lost, You will get paid for the ski racks but I won't verify that this Radar doctor was in the car!" I said "I didn't ask you to feel sorry for me, but wearing a badge doesn't give you the right to take things that aren't yours."

When I left the office I heard him say "Oh Shit." His attitude makes me think he knows something about the missing items.

Also missing from the house is my work ledger and my business licence which was still in the envelope that it was mailed to me in. Isn't taking someone's mail a Federal offence? The envelope was in the ledger and the ledger was under my invoice book. They gave me the invoice book back, but they can't find the ledger and business licence. I would like to get my license back.
