## PARCEL 1

A tract of land located in Government Lot 4 of Section 8, Township 3 North, Range 8 East of the Willamette Heridian, Skamania County, Washington described as follows:

Beginning at the Southwest corner of the said Section 8; thence East along the South line of the Said Section 8 a distance of 250 feet to the initial point of the tract hereby described; thence North 00° 12" East parallel with the West line of said Section 8, 130.89 feet; thence North 54° 52' 12" East to intersection with the Southwesterly right of way line of State Secondary Highway No. 8-C; thence Southeasterly following said right of way line to a point 600 feet East of the West line of said Section 8; thence South parallel with the West line of said Section 8 to the South line of said Section 8; thence West to the initial point.
