AND JUDGMENT



IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the defendants should be and hereby are found to be in default herein.



IT IS FURTHER ORDERED, ADJUDGED AND DECREED that said judgment shall bear interest at the rate of ten per cent (10%) per annum from the date hereof.


