

TERMINATION OF AGREEMENT

WHEREAS, by AGREEMENT, dated March 9, 1988, as recorded in the Records of Skamania County, Washington, in Volume 108, Page 824, PUBLISHERS FOREST PRODUCTS CO. OF WASHINGTON, a Washington corporation, and WEYERHAEUSER COMPANY, a Washington corporation, granted each to the other certain road use rights for roads located in Sections 22 and 23, Township 7 North, Range 5 East, W.M., Skamania County, Washington.

WHEREAS, said AGREEMENT expired by its own terms on March 30, 1990.

WHEREAS, the parties agree that said AGREEMENT will not be extended and that a formal termination shall be executed and filed so that each party's title will not be encumbered by said AGREEMENT.

NOW THEREFORE, PUBLISHERS FOREST PRODUCTS CO. OF WASHINGTON, a Washington corporation, and WEYERHAEUSER COMPANY, a Washington corporation, hereby each quit claim and release unto the other, all right, title and interest each may have in and to the easement rights across the lands of the other by virtue of said AGREEMENT.




