A tract of land in the Southeast quarter of the Northwest quarter Section 8, Township 1 North Range 5 East Willamette Meridian, described as follows:

Beginning at the Northeast corner of the Southeast quarter of the Northwest quarter; thence South 330 feet along the East line of the Southeast quarter of said Northwest quarter to the true point of beginning; thence continue South along said East line 330 feet; thence West parallel to the South line of the Northwest quarter a distance of 660 feet; thence North parallel with the East line of said Northwest quarter a distance of 330 feet; thence East parallel with the North line of said Northwest quarter a distance of 660 feet to the true point of beginning.

NOTE: Investigation should be made to determine if there are any service, installation, maintenance or construction charges for sewer, water, telephone, gas, electricity or garbage and refuse collection, or any covenants, conditions and restrictions under which an estate, lien or interest in property has been, or may be, cut off, extinguished or otherwise impeded.
