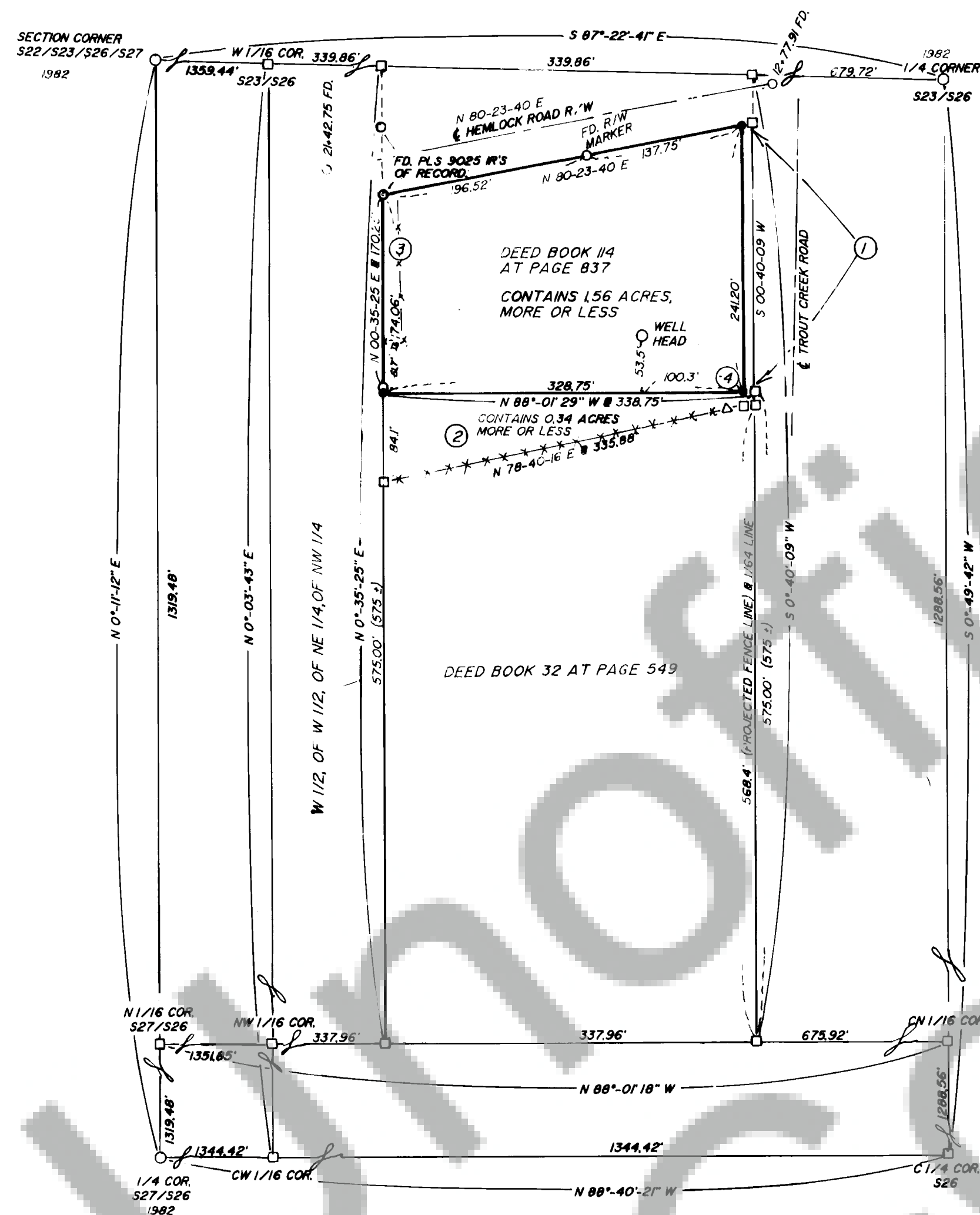
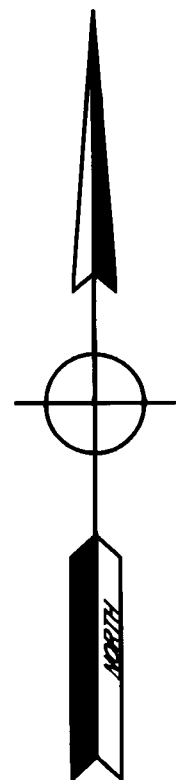

## NOTES

- ① DEED BOOK 114, PAGE 837 EXCEPTS OUT TROUT CREEK ROAD IN ITS ENTIRETY. THE COUNTY RIGHT OF WAY MAP DATED 6/10/1939, SHOWS THE WEST RIGHT-OF-WAY LINE AS BEING 10' WEST OF THE '164 LINE AND PARALLEL TO IT AS SHOWN.
- ② DEED BOOK 32, PAGE 549 HAS AMBIGUITIES, 2 OF WHICH ARE AS FOLLOWS:
  - (A) "TO THE BANK OF THE CREEK" DOES NOT SAY WHICH BANK. ALTHOUGH, THE "575' MORE OR LESS" APPEARS TO FAVOR THE SOUTH BANK.
  - (B) "THENCE WEST" DOES NOT APPEAR TO IMPLY CARDINAL DIRECTION OR RIGHT ANGLE DIRECTION IF THE EXISTING FENCE IS TAKEN INTO CONSIDERATION.

THESE LATENT AMBIGUITIES SHOULD BE TAKEN INTO CONSIDERATION BEFORE ANY PERMANENT STRUCTURES ARE PLACED ON THE AREA BOUNDED BY MY IRON RODS SET AT 575' AND THE EXISTING FENCE ALONG THE SOUTH CREEK BANK.

- ③ PLEASE REFER TO PLS9025'S SURVEY IN BOOK 1, PAGE 223, OF JANUARY, 1980, FOR ENCROACHMENTS. THESE STRUCTURES ARE STILL PRESENT UPON THE SURVEYED LAND. CONTAINS ±1,950 SQUARE FEET
- ④ UNITED TELEPHONE SYSTEM VAULTS, LOCATED 25 FEET BY 25 FEET AT THE SOUTHEAST CORNER OF PROPERTY. CONTAINS ±625 SQUARE FEET

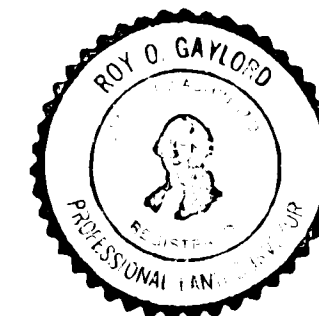
