EASEMENT DEED

I, SUSAN LEE BLEGEN, formerly known as SUSAN LEE NIELSEN WOOSLEY, a married woman dealing with her sole and separate estate, of Mill-A, Skamania County, Washington, for good and valuable consideration, receipt of which is hereby acknowledged, do hereby grant, bargain, and convey to WILLIAM PATRICK FARRELL and LINDA JO FARRELL, husband and wife, a perpetual easement, ten feet (10') in width, for the purposes of constructing, maintaining and repairing a water storage tank and pipeline to hold and to carry a domestic water supply over and across the following described real property:

Lot 3 of the NIELSEN SHORT PLAT which is located in Lots 2 and 3 of Block 11 of Manzanola Orchards in the Southwest Quarter of the Southeast Quarter of Section 10, Township 3 North, Range 109 East of the Willamette Meridian, according to the official plat thereof, recorded in Book 3 at Page 168 under Auditor's File No. 109682 of the Deed Records of Skamania County, Washington.

The real property to which this easement appurtenant is Lot 2 of said NIELSEN SHORT PLAT.

The easement and right of way granted in this Easement Deed is more particularly described as follows:

Beginning at a spring located approximately 100 feet North of the Southwest corner of said Lot 3 of the NIELSEN SHORT PLAT, thence Easterly along an existing access drive to the point where said drive meets a private roadway commonly known as the Carr Road Extension; thence Southerly along said Carr Road Extension to the Northern boundary of Lot 2 of said NIELSEN SHORT PLAT.

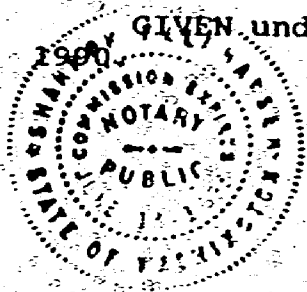
