That portion of the following described property lying Northeasterly of the Northeasterly line of the Wind River Highway:

The H.E. Survey No. 232, filed in Book 2 of surveys on page 181, embracing a portion of Section 25, Township 4 North, Range 7 East of the Willamette meridian, Skamania County, Washington, more particularly described and bounded as follows:

Beginning at Corner No. 1, from which the Southwest corner to said Section 25 bears North 89° 45' West 5.84 chains distant; thence North 18° 32' West 10.63 chains to Corner No. 2; thence North 48° West 3.83 chains to Corner No. 3; thence North 00° 30' West 12.76 chains to Corner No. 4; thence South 70° 04' East 12.41 chains to Corner No. 5; thence South 40° 17' East 27.85 chains to Corner No. 6; thence North 89° 45' West 23.31 chains to Corner No. 1, the place of beginning.

and does hereby assign, transfer and set over to the Grantees that certain real estate contract dated the 28th of March, 1985, between Robert K. Garwood, Trustee under Trust Agreement dated January 17, 1984, as Seller, and August T. Gehrig, as his separate estate, as Purchaser, for the sale and purchase of the above-described real estate. The Grantees hereby assume and agree to fulfill the conditions of said real estate contract, and the Grantor hereby covenants that there is now unpaid on the principal of said contract the sum of \$33,500.00.

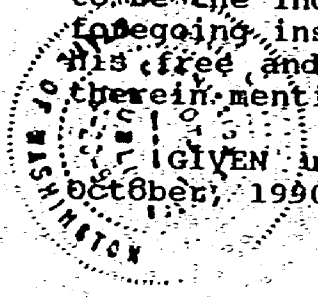
