## MEMORANDUM OF DEED

## CONVEYING REAL ESTATE IN TRUST

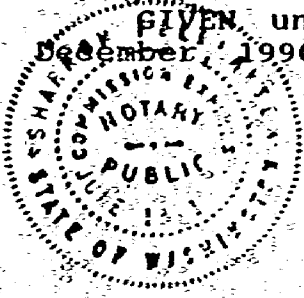

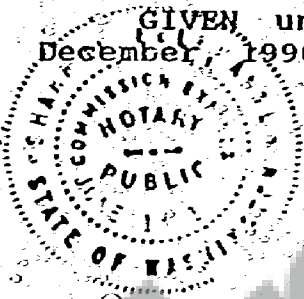
