Kirkman by deed dated April 7, 1908 and recorded at page 67 of Book "L" of Deeds, records of Skamania County, Washington, said point now being located within the right-of-way acquired by Skamania County for County Road No. 2028 designated as the Loop Road; thence within said right-of-way and following the centerline of said road North 46° 05' West to intersection with the North line of the said Section 25 a distance of 400 feet, more or less, to a point North 03° West from the point of beginning; thence South 03° East 347 feet, more or less to the point of beginning.

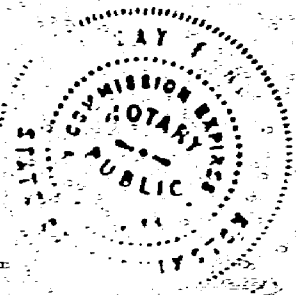
