

DEED OF RELEASE

St. Louis, Missouri. February 21, 1991

In consideration of the payment of the indebtedness mentioned in a certain deed of trust dated August 4, 1975 and recorded in the Recorder's Office of the County of Skamania, State of Washington in Book 52 Page 790, the Jefferson Savings and Loan Association, a Missouri Corporation. The owner of the Note described in said deed of trust, does hereby release and reconvey the property described in said deed of trust to:

The Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$) and the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 27, Township 3 north, Range 9 E.W.M.; EXCEPT the north 500 feet of each of said subdivisions; AND EXCEPT a tract of land conveyed to School District No. 25 by deed dated March 19, 1915, and recorded April 6, 1915, at page 233 of Book P of Deeds, Records of Skamania County, Washington; AND EXCEPT that portion thereof conveyed to Ray M. Jackman and Loree Jackman, husband and wife, by deed dated April 28, 1962, and recorded May 3, 1962, at page 513 of Book 49 of Deeds, under Auditor's File No. 59863, Records of Skamania County, Washington;

the grantors therein, their heirs and assigns forever discharged from the lien of said deed of trust.

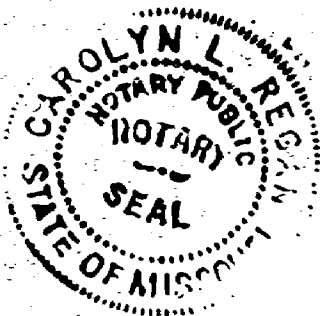
