## AMENDED MEMORANDUM OF OPTION

That certain Memorandum of Option dated January 18, 1991, and recorded January 30, 1991 in Book 122 at Page 111 of the official records of Skamania County, Washington is hereby amended to read as follows:

This is a Memorandum of a certain Option Agreement dated as of April 25, 1991, between MURRAY SAM ALTORFER and CHRISTINE ROBIN ALTORFER, a husband and wife ("Seller"), and THE TRUST FOR PUBLIC LAND, a California nonprofit public benefit corporation ("Buyer"). By said Option Agreement Seller has granted to Buyer an exclusive option of purchase that certain real property in Skamania County, Washington described as follows:
