9 Patrick T. Kelly and Elizabeth Kelly (the "Defendants").



11 The Court having read and considered the Motion and all
12 papers, pleadings and declarations on file herein; having
13 considered oral argument and the evidence presented herein;
14 having found that the Court has jurisdiction to rule on the Motion
15 pursuant to the United States District Court for the Central
16 District of California's Order Re Propriety of Removal And
17 Referral To Bankruptcy Court entered September 25, 1990 and
18 Amended Referral Order entered October 4, 1990; and, having found
19 that proper notice was given; the Court concludes that there are
20 no triable issues of material fact with respect to the Bank's
21 allegations that the Defendants are liable to the Bank under their
22 guaranty of debtor Defense Technologies, Inc.'s indebtedness to


