QUIT-CLAIM DEED

Bonneville Second Powerhouse
Project, Relocated Hwy SR-14
Right-of-Way Acquisition

THE GRANTOR, THE WAUNA LAKE CLUB, a corporation duly organized and existing under and by virtue of the laws of the State of Washington, having its principal place of business at Stevenson, in said State, for and in consideration of Six Hundred Fifty and No/100 Dollars (\$650.00) conveys and quit claims to the UNITED STATES OF AMERICA and its assigns, GRANTEE, the following described real estate, situated in the County of Skamania, State of Washington, including any interest therein which the grantor may hereafter acquire:

A tract of land situated in Section 14, Township 2 North, Range 7 East of the Willamette Meridian, Skamania County, Washington, being more particularly described as follows:

Commencing at the intersection of the northerly right-of-way line of the former Evergreen Highway No. 14 with the west line of said Section 14; thence N. 54°45'00" E. along said northerly right-of-way line, 425.00 feet to the southeast corner of that certain parcel of land acquired by the U.S.A. from Edna M. Gauley identified as Tract 2923 and recorded in Book 69 at Page 468 of the records of said Skamania County, and being the POINT OF BEGINNING;

thence N. 06°06'00" E. along the easterly line of said Tract 2923, 170.00 feet, more or less, to the northerly right-of-way line of the Relocated State Highway No. 14;

thence N. 83°08'17" E. along said relocated highway right-of-way line, 38.00 feet, more or less, to the centerline of that private roadway known as Wauna Lake Road;

thence southwesterly along the centerline of said roadway to the northerly right-of-way line of said former Evergreen Highway;

thence S. 54°45'00" W. along the northerly right-of-way line of said former Evergreen Highway, 20.00 feet, more or less, to the point of beginning.

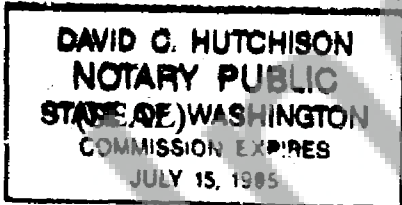
