Beginning at a point marked by an iron pipe, said point being the intersection of the centerline of Vancouver Avenue and Kanaka Creek Road; thence Northerly along the centerline of Kanaka Creek Road a distance of 420 feet, more or less, to a point which bears South  $61^{\circ}40'$  West from an iron pipe on the West Bank of Kanaka Creek; thence North  $61^{\circ}40'$  East to the centerline of Strawberry Road to the true point of beginning; thence continuing North  $61^{\circ}40'$  East 156 feet, more or less, to said iron pipe; thence continuing North  $61^{\circ}40'$  East 20 feet, more or less, to the centerline of Kanaka Creek; thence following the centerline of Kanaka Creek in a Northerly direction to the centerline of Strawberry Road; thence following the centerline of Strawberry Road in a Southerly direction to the true point of beginning.
