6. Filing of a child day care registration form with Skamania County as provided for in Section 21.86.060 of this chapter;

7. No structural or decorative alteration which will alter the single-family character of an existing or proposed residential structure or be incompatible with surrounding residences is permitted.

B. A family day care home may be allowed in all other zone classifications only upon issuance of a Conditional Use Permit pursuant to Chapter 21.16.060.

21.86.040 CHILD MINI-DAY CARE CENTER

Child mini-day care center not located in the residence of the care provider shall be permitted in R-1, R-1A, R-2, R-5, R-10, and Community Commercial zone classifications and shall be subject to Administrative Review.

- A. Notice. Notice of the proposal shall be posted on site at least ten (10) days prior to final action on the application; and shall include a description of the proposal, site location, deadline for submitting written comments, and the address and phone number of the County Planning Department.
- B. Administrative Review. The Planning Director shall review applications for a mini-day care center not located in the residence of the care provider and may approve, modify, or deny the application subject to the following requirements:
 - Meet Washington State child day care licensing requirements;
 - Comply with all building, fire safety, health code, and business licensing requirements:
 - business licensing requirements;
 3. Signage, if any, will conform to the requirements of Chapter 21.84.100;
 - Filing of a child day care registration form with Skamania County as provided for in Section 21.86.060 of the chapter;
 - Parking requirements shall comply with Chapter 21.84.060;The site must be landscaped in a manner compatible with
 - adjacent residences;
 No structural or decorative alteration which will alter the residential character of an existing residential structure used for a child mini-day care center is permitted. Any new or remodeled structure must be designed to be compatible with the residential character
 - of the surrounding neighborhood;
